Release and Waiver of Liability

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____, 2026, by _____ (the "Volunteer") in favor of Side by Side in Service, a nonprofit corporation, and its directors, officers, employees, and agents.

The Volunteer desires to work as a volunteer for **Side by Side in Service** and engage in the activities related to being a volunteer for **Side by Side in Service**.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless **Side by Side in Service** and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that arise or may hereafter arise from Volunteer's Activities with **Side by Side in Service**.

VOLUNTEER UNDERSTANDS THAT THIS RELEASE DISCHARGES **Side by Side in Service** FROM ANY LIABILITY OR CLAIM THAT THE VOLUNTEER MAY HAVE AGAINST **Side by Side in Service** WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS,

DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM VOLUNTEER'S ACTIVITIES WITH **Side by Side in Service**, WHETHER CAUSED BY THE NEGLIGENCE OF **Side by Side in Service** OR ITS OFFICERS, DIRECTORS, EMPLOYEES, OR AGENTS OR OTHERWISE. VOLUNTEER ALSO UNDERSTANDS THAT **Side by Side in Service** DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE IN THE EVENT OF INJURY OR ILLNESS.

2. **Medical Treatment.** Volunteer does hereby release and forever discharge **Side by Side in Service** from any claim whatsoever which arises or may hereafter arise on account of any First Aid, treatment, or service rendered in connection with the Volunteer's Activities with **Side by Side in Service**.

3. **Assumption of the Risk.** The Volunteer understands that the Activities may involve work that may be hazardous to the Volunteer, including, but not limited to, **[Insert types of work the volunteer will perform]**, and transportation to and from the work sites. 5. **Photographic Release.** Volunteer does hereby grant and convey unto **Side by Side in Service** all right, title, and interest in any and all photographic images and video or audio recordings made by **Side by Side in Service** during the Volunteer's Activities with **Side by Side in Service**, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

6. **Other.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of **Georgia**, and that this Release shall be governed by and interpreted in accordance with the laws of the State of **Georgia**. Volunteer also agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
